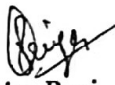

1. Accordingly, we are unable to comment on the impact of the same on results for the quarter ended June 30, 2021.

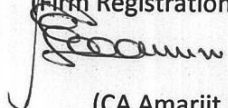

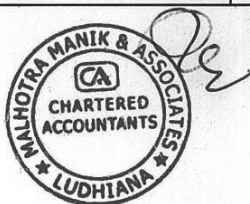

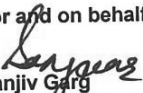
